Collin County Health Care Services (CCHCS) reports 18 new COVID-19 cases in Collin County, including 6 in Plano. The total number of positive cases in Collin County is 710, including 209 in Plano. The County has 204 active cases, including 66 in Plano.

CCHCS reported one new COVID-19 related deaths, an 83-year-old Plano woman who had underlying health conditions. Her passing is Plano's third death and the 20<sup>th</sup> in Collin County. Her zip code has not been reported.

There are four cases in the Denton County portion of Plano. Three have recovered and one is in isolation at home. With the Denton County cases, the total number of positive cases in Plano is 213.

8024 people have been tested for the virus in Collin County. 7281 tested negative. 710 tested positive. 33 tests are pending.

1,115 people are currently under monitoring (PUM) in Collin County, including 294 in Plano. A PUM is an asymptomatic person with an epidemiologic exposure to the COVID-19 virus. The exposure may be close contact with a confirmed case or with their infectious secretions or clinical specimens; or designation as a PUM by CDC.
